We hereby make application to Greyhound Racing NSW (GRNSW) for registration of the abovementioned Syndicate and in consideration GRNSW granting such application we hereby agree:

- to, at all times, observe and be bound by the Rules of Greyhound Racing and the Greyhound Racing Act 2009, and all applicable rules and laws in force from time to time during the currency of this registration and all decisions and directions by GRNSW that it is empowered to make or give.
- that any Certificate of Registration which may be issued to us is, and will remain the property of GRNSW and will be produced on demand made by an authorised official.
- that GRNSW accepts no liability or responsibility howsoever arising from disputes between members of the Syndicate. Any disputes between members of the Syndicate will be a private matter between members of the Syndicate and GRNSW will take no part on such disputes.
- to promptly advise GRNSW of any changes to the composition of the Syndicate.

NOMINATED SYNDICATE MANAGER

The Syndicate hereby nominates the following person (who has signed this application by way of confirmation) to act as the Delegated Syndicate Manager for the above Syndicate. This person is entitled to, and shall:

- exercise on behalf of the Syndicate any powers which the Syndicate as Owner of a greyhound may exercise, including;
 - power to nominate a greyhound for, or withdraw a greyhound from, an Event;
 - receive any prizemones payable in respect of any greyhound raced by the Syndicate;
 - signing and executing documents on behalf of the Syndicate;
 - changes to the ownership or naming of the greyhound.
- receive any document or notice required to be served under the Rules on any member of the Syndicate;
- be deemed to be authorised to act for or on behalf of the other Syndicate member unless otherwise provided in the Rules, and
- act on behalf of the Syndicate in all matters.

A Syndicate may change its Nominated Manager by providing written notice to GRNSW which is signed by the joint members of the Syndicate, representing the majority shareholding of at least 51% in the ownership of the greyhound.

No greyhound owned by a Syndicate shall be nominated for, or be allowed to participate in, any event if any member of the Syndicate is undergoing a period of disqualification, suspension, warning off or listed as a defaulter (LR 99).
