Indemnity:

The beekeeper (transferee) agrees to indemnify the Director General from and against liability for all actions, suits, demands, costs, losses, damages and expenses (claims) (e.g. search and rescue costs) which may be brought against or made upon the Director General caused by or arising in any way out of the conduct of:

- (i) the beekeeper
- (ii) the beekeeper's employees, agents or contractors; and in relation to this authority or the beekeeper's operations.

Insurance:

The beekeeper shall at all times during the period of the authority maintain a policy of public liability insurance, that covers the areas and operations allowed under the licence or permit in the name of the authority holder to the extent of its respective rights and interests for a sum not less than 10 million dollars (\$10,000,000) per event.

a The beekeeper shall provide the Director General proof of the existence and currency of such insurance policy whenever requested by the Director General during the term of the licence.

b The beekeeper shall pay all premiums of the public liability insurance policy when they are due, comply with all of the terms of that insurance policy and shall make the insurer aware of the licence, these conditions and the indemnity given to the Director General.

The beekeeper (Transferee) applies to accept the apiary authorities listed within this form by way of a transfer to enter upon and use the apiary sites specified in this application and understand and agree that the authority, if transferred, will be subject to the provisions of the Conservation and Land Management Act 1984. and all subsidiary legislation made under it.

I/we certify that to the best of my/our knowledge the information provided within this application is true and correct in every detail.

I/We have read, understood and agree to abide by the general conditions (available from DPaW's website www.dpaw.wa.gov.au/beekeeping, and I/We understand that further conditions relevant to the sites proposed in this application may apply.

I/We understand that the authorities (if approved to be transferred) will retain the expiry date shown on each current authority issued to the Transferor. If authorities are to be transferred during the same year as the expiry date on the authority DPaW will be required to reassess the authority prior to transferring the site. Apiary authorities are not 'automatically' renewed and are subject to re-assessment at the time of renewal.

I/we understand that any agreement to purchase an authority from another beekeeper should be subject to the completion of the transfer. Transferees are encouraged to discuss with the local district apiary officer whether there are any issues that may affect any authorities being transferred and or not renewed beyond the current expiry date.

I/we understand that DPaW encourages the transferees to visit the site under each authority they wish to obtain to ensure there is physical access to the site.
