Permit to Purchase a Non-Prohibited Firearm on Leaving Australia

This FACT sheet provides information on the requirements for obtaining a Permit to Purchase a Non-Prohibited Firearm on Leaving Australia - clause 49 of the *Firearms Regulation 2006*.

Persons leaving Australia, who wish to purchase a non-prohibited firearm prior to departure, must obtain a permit authorising the purchase of the firearm.

[What does a Permit to Purchase a Non-Prohibited Firearm on Leaving Australia authorise?](#)

This permit authorises a person to purchase a firearm (other than a prohibited firearm) for the purposes of conveying the firearm outside Australia.

This permit does not authorise the permit holder to take physical possession of the firearm.

The applicant must nominate a Firearms Dealer, the permit will be forwarded directly to the nominated Firearms Dealer and the Firearms Dealer or his/her agent will arrange delivery of the firearm directly to the Australian Customs Service.

The permit does not authorise the use of the firearm or the purchase or possession of ammunition for the firearm.

[What is the term of this permit?](#)

The permit is issued for seven (7) days or until the firearm is purchased, unless surrendered or revoked, whichever occurs first.

[How much will my permit cost?](#)

The prescribed fee for this permit is AUD \$75. Your payment must accompany the application.

[What type of firearm and I able to purchase with this permit?](#)

You may purchase one of the following types of firearms only:

- * Air rifle; or
- * Rimfire rifle (not self-loading); or
- * Shotgun (not self-loading or pump action); or
- * Shotgun/rimfire rifle combination; or
- * Muzzle loading firearms (other than pistols); or
- * Centre-fire rifle (not self-loading); or
- * Shotgun/centre-fire rifle combination, or
- * Pistols.

[Can I export more than one firearm on this permit?](#)

No. Only one firearm per permit is allowed. If you wish to export two firearms you will need to make application for two permits.

[How do I apply for a Permit to Purchase a Non-Prohibited Firearm on Leaving Australia?](#)

You must complete the P634 'Application for a Firearms Permit' form and the 'Purchase a Non-Prohibited Firearm on Leaving Australia Legitimate Reason' form and where applicable provide any supporting documentation. Instructions for completing the Firearms Permit Application Form

FIREARMS PERMIT APPLICATION FORM (P634)

NEW APPLICATION / REAPPLICATION

Mark appropriate box (new application or reapplication) and insert any previous or current firearms licence or permit number.

SECTION A - PERMIT TYPE

From the drop down list select the type of permit relevant to this application. If the permit is not listed in the drop down list, enter the type of permit you require in the space provided.

SECTION B - NOMINATED PERSON/BUSINESS OR NOMINATED PERMIT HOLDER/INDIVIDUAL

Insert your full name, date of birth, gender, NSW drivers licence (if held), contact phone numbers, email address and supply details if you have been known by any other names.

SECTION C - RESIDENTIAL ADDRESS

Insert your full residential address in this section.

SECTION D - POSTAL ADDRESS

If the postal address is the same as the residential address, mark the box. If your postal address is different to your residential address, insert your postal address in this section.

SECTION E - BUSINESS, CLUB OR GOVERNMENT AGENCY DETAILS

If this application is being made by a Business, Club or Government Agency, provide details in this section and attach supporting documentation.

SECTION F - SAFEKEEPING ADDRESS OF FIREARMS

If the safekeeping address is the same as the residential address, select 'YES' in the box. If your firearm safekeeping address is different to your residential address, insert the address in this section.

SECTION G - PERSONAL HISTORY

Answer each question by selecting a 'YES' or 'NO' from the drop down list. If you answer 'YES' to any question, provide details as an attachment.

SECTION H - DECLARATION

The application must be signed and dated by the applicant.

SECTION I - FEE

The prescribed fee for this permit is AUD \$75. Your payment must accompany the application.
