 - (ii) CPPDSM4008A—Identify legal and ethical requirements of property sales to complete agency work.
2. A person has the qualifications required for the issue of a certificate of registration as a stock and station salesperson if the person has held a certificate of registration as a stock and station salesperson in the 12 months preceding the making of an application for the equivalent certificate of registration.
3. A person has the qualifications required for the issue of a certificate of registration as a stock and station salesperson if the person has the qualifications required for the issue of a stock and station agent's licence. Certificate of registration as a registered strata manager or registered community manager

 - (ii) CPPDSM4007A—Identify legal and ethical requirements of property management to complete agency work.

A person has the qualifications required for the issue of a certificate of registration as a registered on-site residential property manager if the person has held a certificate of registration as a registered on-site residential property manager in the 12 months preceding the making of an application for the equivalent certificate of registration.
3. A person has the qualifications required for the issue of a certificate of registration as a registered on-site residential property manager if the person has the qualifications required for the issue of an on-site residential property manager's licence. Certificate of registration as a business salesperson

 - (ii) CPPDSM3019B—Communicate with clients as part of agency operations,AND
 - (b) all of the following units of competency:
 - (i) CPPDSM4079A—Work in the business broking sector,
 - (ii) CPPDSM4008A—Identify legal and ethical requirements of property sales to complete agency work.
2. A person has the qualifications required for the issue of a certificate of registration as a business salesperson if the person has held a certificate of registration as a business salesperson in the 12 months preceding the making of an application for the equivalent certificate of registration.
3.
