- i** You must be able to provide evidence to prove: ✓ Ownership/occupancy of rural land, **or**
✓ Permission to shoot, **or**
✓ Hunting club membership, **or**
✓ Permission from government agency, **or**
✓ Game Council 'R' licence.

PRIMARY PRODUCTION You may only select A B C

- i** You must be able to provide evidence of: ✓ Occupation as a primary producer, **or**
✓ Ownership, lessee or manager of land used for primary production.

Note: If you wish to shoot on properties other than the primary production property nominated, you will also need to apply for the genuine reason of Recreational Hunting/Vermin Control (except for category C - see FACT Sheet).

VERTEBRATE PEST ANIMAL CONTROL You may only select A B D
(You must also select from the following)

- Contract Shooter** **Government Agency Employee** **Primary Producer - Eradication Campaign**
- i** You must be able to provide evidence that you are a professional contract shooter. **i** You must be able to provide evidence that you are employed or authorised by a Government Agency **i** You must be able to provide evidence that you are a primary producer and involved in an authorised eradication campaign.

BUSINESS OR EMPLOYMENT You may only select A B H
(You must also select from the following)

- Security Industry - Security Guard** **Security Industry - Business**
- i** You must be the holder of a 1F licence issued under the *Security Industry Act 1997*. **i** You must be the holder of a Master Security Licence and be able to demonstrate that the use of firearms is necessary.
- Commercial Fishing** **Business or Employment - Other**
- i** You must be able to provide evidence that you own or are employed in a commercial fishing business. **i** You must be able to demonstrate that the use of a firearm is necessary in your business or employment.

RURAL OCCUPATION You may only select A B

- i** You must be able to provide evidence that you are employed or engaged in a rural occupation requiring the use of firearms.

ANIMAL WELFARE You may only select A B
(You must also select from the following)

- RSPCA or Animal Welfare League** **Veterinary Practitioner**
- i** You must be able to provide evidence that you are an officer of the RSPCA or Animal Welfare League. **i** You must be able to provide evidence that you are a veterinary practitioner.
- Handler of Animals** **Dept Primary Industries or Livestock, Health & Pest Auth**
- i** You must be able to provide evidence that you are the owner, transporter, drover or other handler of animals. **i** You must be an employee of the Department of Primary Industries or Livestock, Health & Pest Authorities.

FIREARMS COLLECTION You may only select A B C D H

- i** You must be able to provide proof of current membership of an approved Collectors Club or Society.
