E) CONDITIONS OF CONSENT:

- ii) The permit holder must hold public liability insurance of not less than five (5) million dollars.
- iii) The permit will expire when the ownership of the business is transferred or the business ceases to operate.
- iv) This permit can be revoked at any time.
- v) The area must be kept clear of litter at all times.
- vi) The permit holder must indemnify Council against any damages.
