- ◆ signage that does not unreasonably impact on the access to views, sunlight or breezes for residents on adjoining sites or create nuisance as a result of noisy, flashing or illuminated devices;
- ◆ signage that reflects the character of specific areas of the City, particularly areas with a predominant history character or notable urban design theme;
- ◆ signage that does not detract from the operation and safety of the major arterial road routes in the City; and
- ◆ signage that complements the objectives to provide attractive tourist gateway routes into and out of the City
