SCHEDULE OF RESTRICTED AREAS

'GENERAL BUSKING' PERMIT HOLDERS:

- Busking is not permitted in relation to Special Events unless busking forms part of that event or specific invitation is granted by the Inner City Facilities Manager.
- Must be minimum 10 metres from Outdoor Dining Areas (unless written invitation has been supplied by the business)
- Must be minimum 10 metres from Licensed Venues (unless written invitation has been supplied by the business)
- Must be minimum 10 metres from Market Stalls, both at the Esplanade and City Place
- Must allow a minimum 2 metre pedestrian corridor parallel to any roadway.
- Busking is not permitted within 10m from the following businesses:
 - Cairns Esplanade: Baskin & Robbins / Aussie Bush Hats / Didgeridoo shop / Happy Herb shop / Money exchange / Coffee Club.
 - Shields Street: Gear Clothing / Lorna Jane
- Percussion (excluding drums) allowed on The Esplanade only.

'SPECIAL BUSKING' & 'Circle Act' PERMIT HOLDERS:

- Are restricted to City Place Centre, Esplanade Shields St Plaza and Esplanade Beach area at start of boardwalk, or adjacent parklands as detailed on attached maps. Fire acts are restricted to City Place, Esplanade Plaza or Esplanade Beach areas only.
