

## MACKAY REGIONAL COUNCIL BUSKING PERMIT

This permit is issued in accordance with provisions of *Mackay City Council Local Law No. 75* (Commercial Use of Roads) and the following conditions apply to the permit:

- 1. Busking is defined as playing a musical instrument and/or singing, conjuring. juggling, mime, mimicry, dance, puppetry. performance art, recitation and other appropriate theatrical and visual form.
- Directions of members of the Police or authorised officers of the Council must be complied with at all times.
- 3. The permit holder shall not advertise or associate himself or herself with advertising in conjunction with any performance.
- 4. The use of amplifiers is prohibited.
- 5. No nuisance shall be committed.
- 6. There shall be no undue obstruction to pedestrian or vehicular traffic and entrances to shops and buildings shall be kept clear at all times.
- 7. The direct collection or soliciting of donations is prohibited.
- 8. The permit holder must not interfere in any way with an approved entertainment or activity.
- 9. A permit holder shall not sell, offer or expose for sale any articles or commodity.
- 10. The permit is not transferable.
- 11. Consent from adjacent property occupants must be obtained for each proposed busking location.
- 12. The Permit Holder is to vary the location of the performance. No site should be used for more than three (3) hours in an eight (8) hour period.
- 13. Any busking must not take place within 10 metres of licensed premises.
- 14. Busking or entertainment is not permitted on the footpath in Wood Street (between Gordon Street and River Street) or Victoria Street (between Sydney Street and Gregory Street) on any Sunday between 8am and 1pm, without approval from the City Centre Market organiser.
- 15. Busking or entertainment is not permitted in any public place during the course of any approved openair market or community event without specific permission from the organiser of that market/event.
- 16. Busking may not be performed between the hours of 3am and 6am.

Please Note, all forms of amplification are prohibited and your attention is drawn to Condition No. 16.
