FORM 1 IS TO ENABLE A BUSINESS USING THE TERM “ARCHITECT” OR “REGISTERED ARCHITECT” OR OTHER TERM PRESCRIBED UNDER SECTION 114(1)(b) OF THE ARCHITECTS ACT 2002 IN ITS COMPANY OR BUSINESS NAME TO GIVE NOTICE TO THE BOARD OF ARCHITECTS OF QUEENSLAND PURSUANT TO SECTION 141A(2) OF THE ARCHITECTS ACT 2002.

General Information about this Notice:

If this notice is kept current, its effect is to enable a business to use the title “architect” or “registered architect” or other term prescribed pursuant to section 114(1)(b) of the *Architects Act 2002* in its business or registered business name without thereby automatically offending against sections 113(1), 114(1), or 140(1)(a) of the *Architects Act 2002*. Further information about the effect of this notice may be obtained from the Board or found on the Board’s website: www.boaq.qld.gov.au

To have any effect the information provided by the business must be kept current and correct and section 141A(5) provides that a business must give the Board a NOTICE OF CHANGE IN PARTICULARS (Form 2) under section 141A(5) within 21 days after a change happens to the business’s name, business address or telephone number, the places at which the business provides architectural services using an architect, or in the architects responsible for carrying out architectural services for the business. A NOTICE OF CHANGE IN PARTICULARS (Form 2) may be downloaded from the Board’s website.

The Board takes no responsibility for ensuring that information regarding business notices is current or correct and will **not** issue annual reminders concerning the information contained herein.

ALL the information provided on the Form 1 Notice will be available to the public. The Board reserves the right to notify any architects nominated as responsible architects on this form that they have been so nominated or removed. The *Architects Act 2002* gives the Board the right to include any other information on the record which has been provided to the Board which leads it to reasonably suspect information kept on the record may have changed.
