It is therefore strongly advised that potential transferees check the register of demerit points, and also check with the Marine & Rescue Services of the Tasmania Police with regards to any pending charges which may have been or will be laid against the transferor, which may cause demerit points to be allocated against the licence in the future.

The Department does not check applications against the demerit point register or for any pending charges against the transferor and the State and its servants and agents accept no responsibility whatsoever for any loss or damage which may be sustained by a transferee by reason of the fact that demerit points have been allocated to the licence transferred.
