CONCESSIONS**Concession (Pensioner Discount)**

To be eligible for a 50% concession, pensioners must produce one of the following:

1. Pensioner Concession Card
2. Veterans Affairs Card
3. Commonwealth Seniors Health Card together with a Seniors Card
4. State Concession Card

If you are mailing your application, please include a photocopy of the relevant card (showing both front and back of card).

Sterilisation Discount

To be eligible for the sterilised rate you must produce one of the following:

1. Veterinary Surgeon's Certificate
2. Signed Statutory Declaration (obtainable from Shire Administration Office)
3. Authorised Officer sighting ear tattoo

Previous Registration Certificates are **not** acceptable as proof of sterilisation.**PAYMENTS**

Animal Registration Payments can be made:
