## Busking Disclaimer Form

**When busking on public and privately owned land within the Central Business District, agree to comply with the following conditions:**

- The nature of your performance, location and size of your performance area is to be approved and is not to obstruct access to any premise, thoroughfare or pedestrian access way. Any damage to the area surrounding your performance which can be directly related to your actions and which could have been avoided, will be charged to you, payable within 7 days. You must leave the performance area in a clean and tidy condition.
- All instruments, electrical appliances and/or props used by yourself are your responsibility and any injury or death as a result of these will be the full responsibility of yourself. There shall be no signage apart from the sign displaying the name of your performance. No electronic amplification to be allowed for busking or spruiking.
- Activities for the purpose of entertainment or for the collection of money are subject to a maximum frequency being limited to three times per week. No block booking is permitted.
- Spruikers are not permitted because of the disturbance they cause when speaking too loudly in the street.
- When your performance is reported to Council to be of a disturbance to the community or surrounding businesses you may be asked to discontinue your activity by the City Rangers. Should the noise level of the entertainment/activity be of some concern a jointly signed letter from surrounding premises agreeing to the activity is required to be sighted by the Community Development Project Officer for approval. Noise levels must comply with City policies (4.4.2.6) and Environmental Protection (Noise) Regulations 1997.
- You are responsible to obtain your own insurance as the City's public liability insurance does not extend to buskers or individual street performers. Should you choose to perform without personal or public liability insurance it is done so at your own risk.
- If under the age of 18 you must have your Parent or Legal Guardian's consent to busk or perform in the street. Your parent / or Legal Guardian is required to sign the document. If you are under 13 years of age you are required to have a responsible Parent or Legal Guardian in attendance at all times during performances.

The City of Greater Geraldton shall not be liable or responsible for any loss or damage or injury sustained by you, your organisation or its members, or the general public, either personal or proprietary caused by or arising out of any act, neglect, default or misconduct by yourself and / or your members during your period of busking.
