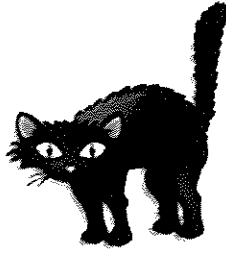

- Cats must be sterilized and microchipped by 6 months of age
- Cats must wear a registration tag when in a public place
- Guide Cat – No Fee
- Cats owned by pensioners – Half the fee otherwise payable (on production of the Pension Concession Card, State Concession Card or a statutory declaration quoting the pension number)
- Cats may be impounded if found to be in contravention of the Cat Act 2011
- Only approved breeders may breed cats
- Any change in particulars contained in this application including change of ownership, the death of a cat and any change in address MUST be notified to Council immediately.
- Age of owner must be 18 years or older
