### CAT OWNER'S RESPONSIBILITIES

The Cat Act 2011 states cat owners must ensure their cat:

- Aged over 6 months must be registered, sterilized and Microchipped. Penalties apply for failing to register you cat(s)
- Wears a collar and registration tag when in a public place

It is a legal responsibility of all cat owners to give notice in writing of any changes of registration details (ie address, phone number, new owner)

### NOTES

Your registration fee helps;

- Reunite lost cats with their owners
- Contributes to the maintenance of the Shire Pound
- Supports Ranger Services within the Shire of Exmouth
- Cat Registrations must be renewed prior to 1 November
- The Shire must be informed immediately of any change of details (i.e. deceased, ownership, address etc).
- Reduced fees apply upon proof of current:
  - i) Pensioner Concession Card;
  - ii) State Concession Card;
  - iii) Commonwealth Seniors Health Card with a WA Seniors Card
