A Driller's Licence can be granted for a period of up to 3 years and is subject to conditions which are specified in the licence. Possession of a current interstate licence equivalent to at least a National Driller's Licence Class 1 can qualify an applicant for an ACT Driller's Licence.

All licences granted under the *Water Resources Act 2007* are included on the Water Resources Register and hence are public documents.
