### 1. When should you complete this form?

You should complete this form if you are an applicant or a licensee and:

- If you are an individual that has changed their name or used any known aliases
- If you are an individual member of a partnership, that has changed their name or has used any known aliases
- If you are an individual director of a company, that has changed their name or has used any known aliases
- If you are a director of a company notifying of a change of the company name (Note: this requires that the ACN of the company is unchanged. Any change to the ACN is a new entity and would require a new application for a licence).

This form is to assist you in providing the required details and allow the prompt assessment of your application. Failure to provide sufficiently detailed information below can affect the outcome of your application as Fair Trading will be unable to assess your circumstances.
