



Western Lands: Addition to a Western Lands Lease Application

Description of Form

This form is used to add Crown Land to an existing Western Lands Lease under s. 28A of the *Western Lands Act 1901*.

Important Information

A lease can only be granted for a specific purpose which will affect the conditions and rent attached to that lease. The land leased must be used for that purpose only.

An application by an incorporated body must bear the Company Seal, and the signatory should indicate his/her capacity/position occupied in the corporation.

The lodgement and acceptance of this application (and deposit) should not be construed as an undertaking or commitment on the part of the Crown to lease the land described.
