**DOG REGISTRATION NOTES**

- Sterilisation papers must be sighted and copied, or the attached Statutory Declaration must be signed.
- Pensioner Card must be presented with each renewal and photocopy attached to registration.
- Statutory Declaration for Droving is to be signed to claim Working Dog rates.
- Only two dogs are to be registered to the one property unless the premises are situated outside of the Town Site, (four) 4 dogs are permissible.
- Any person/s requesting to register a restricted breed must be directed to **Ranger Staff**.
- You must have your dog microchipped and ensure details are correct.
- Dogs must at all times wear a current registration tag attached to their collar, together with a tag bearing the owner's name and current address. This will assist us to reunite you with your dog should it become lost.

- (d) Dogo (Argentinan fighting dog);
- (e) Perro Depresa Canario.
- (f) any other breed of dog the importation of which is prohibited absolutely by Customs (Prohibited Imports) Regulations 1956 of the Commonwealth, and includes any dog of a mixed breed which visibly contains any of the above breeds.
