All applications to keep more than two dogs will ONLY be approved in circumstances where:

- All dog registration requirements are satisfied
- The dogs are not of a restricted breed or declared a dangerous dog
- All adjoining neighbours have provided written consent or have not substantiated reasons for refusal
- Payment of the prescribed fee has been received by the City of Joondalup
- There is no history or current incidence of dog nuisance, wandering or control that is likely to impact on the surrounding community.

Once an application has been received by the City, a Ranger will conduct a property assessment to consider the following:

- There is adequate fencing
- Faeces is not prevalent and is removed regularly
- Size of backyard is adequate
- Consider any history of the dogs i.e. barking, attacks, wandering etc
- Discuss/investigate any barking or other objection received.
