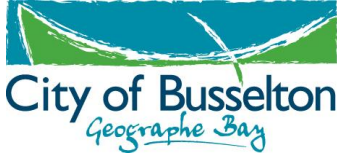

CHECKLIST FOR THE SUBMISSION OF A REQUEST TO ISSUE SECTION 39 AND 40 CERTIFICATES

Liquor Licensing Act 1988

- Submission of Application form

- Submission of Application fee (Section 39 - \$190)
(Section 40/55 - \$138)

- Submission of a copy of an existing Planning Approval (for Section 40/55 Certificate)

- Submission of a written request detailing the following:
 - i. The trading name of the premises;
 - ii. The proposed hours of operation of the premises;
 - iii. Whether liquor is to be available without the requirement for a substantial meal;
 - iv. Whether the premises will feature a “bar” style facility and encourage drinking on the premises in a manner similar to a hotel or tavern style premises;
 - v. What, if any, particular types of persons will the applicants seek to provide for at the premises;
 - vi. Whether liquor will only be sold for consumption on the licensed premises or will be also available for take-away customers in packaged form;
 - vii. Any other matter which may be likely to affect the amenity of the locality in which the premises is located.

Please note that when Section 39 and 40 Certificates are being requested to support a Producer’s Licence application, a Development Application must be approved by the City of Busselton prior to a Section 40 Certificate being issued.

** Please note that a Section 39 Certificate cannot be issued until the premises has been inspected by a City of Busselton Environmental Health Officer. To arrange an inspection, please call the City of Busselton Health Services on 9781 0444.*
