## CAT OWNERS RESPONSIBILITIES

Western Australia's Cat Act 2011 requires;

- Cats aged six months and over must be registered
- Proof of cat being sterilised and microchipped (eg; sterilisation & microchip certificates)
- You must inform the City immediately of any changes in ownership, the death of a cat or any change of address
- Cat registrations must be renewed prior to 1 November. Penalties may apply for failing to renew your cat registration
